### Job Summary

The purpose of the C-Operator position is to assist Plant, Field, and Maintenance Operations as needed. The C-Operator is an entry-level position. As such, they are responsible for learning basic maintenance tasks and becoming Task Trained in the B-Operator positions in both the Plant and the Field. Responsible for supporting a variety of general labor taskings. The position performs a variety of duties such as fire watch, confined space entry watch, painting, washing, shoveling, janitorial, or other labor duties as needed in support of other operating and maintenance teams. This position will perform mainly physical labor including loading, unloading, lifting, and moving supplies and materials. May also assist in operational activities, operations, and maintenance training, fabrication, assembly, and installation of equipment under close supervision. C-Operators are expected to train and become qualified for both Field & Plant B-Operator positions.
